Thembelihle Local Municipality situated in the Northern Cape and covering the towns of Hopetown and Strydenburg, is committed to provide business and job opportunities to its residents.

For this reason tenders are hereby requested from prospective Service Providers to firstly assist with identifying local economic development opportunities and to secondly assist in implementing these projects (for example by PPP's, Private Sector Funding, Donor Funding, Corporate Social Responsibility funding, etcetera).

It must be clearly stated that what the Municipality does NOT want is a local economic strategy covering hundreds of pages, but with no implementable projects. It rather requires the identification of 5 – 10 projects that could be implemented in a relatively short period of time, but will create at least 500 job opportunities.

Opportunities are available in the following areas (but Service Providers are not limited to these):

Prospective Service Providers must have practical experience with tried and tested credentials.

Before compiling your tender, please take cognisance of the following:

- ✓ Thembelihle Local Municipality's Supply Chain Policy will apply.
- ✓ A Valid Original Tax Clearance Certificate for Tenders must be submitted
- ✓ Company profile, ID copies of the company directors and VAT registration must be submitted.
- ✓ Thembelihle Local Municipality does not bind itself to accept the lowest bid or any tender and reserves the right to accept the whole or part of a bid or to accept bids from more than one Service Provider.
- ✓ Late or incomplete; unsigned; electronically and faxed bids will not be accepted.
- ✓ The value of this bid is estimated to not exceed R1 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable. Should the tender amount exceed R1 000 000, then the Supply Chain Management policy determines that the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included) will apply.

- 2.5 Expected number of permanent jobs to be created by each project
