A compulsory clarification meeting will be held on **15 May 2019 at 11h00** at the Municipal Offices corner of Church and Mark Street, Hopetown. Bidders arriving later than 1100hrs will not be allowed to be part of the briefing or to submit their bids.

Fully completed tender documents must be placed in a sealed envelope and placed in the tender box in the Foyer at the Thembelihle Local Municipal Offices Corner Mark and Church Streets, Hopetown or be mailed to reach the Tender Box, Thembelihle Local Municipality, P/Bag X3, Hopetown, 8750 before the closing date of **24 May 2019 at 1100hrs**. The envelopes must be endorsed clearly with the tender number, project title, tenderer's name and closing date and time of the tender as above.

The tender will be evaluated on the 80/20 Preference Points system as prescribed by the Preferential Procurement Regulations, 2017 issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act Number 5 of 2000 (PPPFA) using Method 4 as prescribed by the Standards for Uniformity

The tender box will be emptied just after **1100hrs** on the closing date on **24 May 2019**, after which all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
