## **TENDER NO: TLM 07-2018/19: SUPPLY, DELIVERY AND INSTALLATION OF 654KL ELEVATED WATER TANK WITH TOP COVER & WALK WAY: STRYDENBURG**

Request for Proposals are hereby invited by Thembelihle Local Municipality in terms of Section 111 of the MFMA (No 56 of 2003) and Clause 12(1) of the Municipal Supply Chain Management Policy for the **SUPPLY, DELIVERY AND INSTALLATION OF 654KL ELEVATED WATER TANK WITH TOP COVER & WALK WAY: STRYDENBURG**.

Service Providers must be able to do Elevated Tank Designs, Geotechnical Foundation Engineering Designs and Installation with complete connections to the existing infrastructure. The successful Tenderer must have its own relevant engineers and contractor and should be able to look holistically to the complete project considering the impact of its work on the Installation of Civil Engineering Services which will be implemented at a later stage.

Tenderers must be registered with the necessary Professional and Regulatory Bodies including the Engineering Council (ECSA), The Construction Industry Development Board (CIDB), etc. to ensure all legislative requirements are met and that the installation/construction is done professionally and in line with the Water Act. The Tenderer must be in a position to execute both Civil and Mechanical works and in this regard the following CIDB gradings are both required as a pre-qualification: **4CE or Higher & 4ME or Higher**

Tenderers with prior proven experience in the geotechnical foundation engineering designs, design of elevated steel tanks, supply and installation/construction of elevated water steel tanks projects are entitled to submit tenders.

A compulsory briefing session will be held at 11h00 on **14 May 2019**. The Technical Manager will be present and any questions will then be answered. **NO** further visits to the site will take place. Persons taking interest will gather at the **Municipal Boardroom, Pretorius Street, Strydenburg 8765**. Bidders arriving later than 1100hrs will not be allowed to be part of the briefing or to submit their bids.

Only Tenderers who satisfy the eligibility criteria stated in the Tender Data are eligible to submit tenders. Tenders will be evaluated and adjudicated in line with the Supply Chain Management Policy of the municipality based on the functionality and eligibility criteria.

In accordance with Preferential Procurement Policy Framework Act, 2000: Preferential Procurement Regulations, 2017 Clause 4(1)(a), tenderers must be B-BBEE Contributors. Clause 4(1)(c) 30% of the contract value be sub-contracted out to the following criteria:

- (i) an EME or QSE which is at least 51% owned by black people; and/or
- (ii) an EME or QSE which is at least 51% owned by black people who are youth; and/or
- (iii) an EME or QSE which is at least 51% owned by black people who are women; and/or
- (iv) an EME or QSE which is at least 51% owned by black people with disabilities; and/or
- (v) an EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships.

The sub-contractor must be registered with the CIDB under the ME, having a designation determined in accordance with 30% of the sum tendered or a value determined in terms of the subcontracting works.

Tender documents will be made available at the compulsory clarification meeting. A non-refundable tender deposit of **R 700.00 (Seven Hundred Rand and Zero Cents)** per document, is payable in cash or EFT to:

The following conditions shall apply:

- Council is not obliged to accept any proposal and reserves the right to accept any proposal or portion thereof;
- Proposals shall be valid for a period of 90 days after closing date;
- Proposals will be evaluated and adjudicated in accordance with functionality and eligibility criteria, the Preferential Procurement Policy Framework/Act (Act 5 of 2000), the Preferential Procurement Regulations, 2017 and the Thembelihle Local Municipality's Supply Chain Management Policy.
- Proposals will be subject to an evaluation criterion as set out in the Tender Document.
- Tenderers must be registered on the Central Supplier Database
- The following CIDB gradings are both required as a pre-qualification: 4CE or Higher & 4ME or Higher
- All documentary proof requested in the tender document (e.g. tax clearance certificate, BBBEE certificate, etc.) must be submitted along with the tender document
- Telefax, telegram, email and late tenders will not be accepted.
- Tenders may only be submitted on the original tender document as issued.
- Sealed tenders, appropriately marked with the tender number and project name, must be placed in the tender box at the offices of Tender Box at Thembelihle Municipal Offices, Cnr. Church & Mark Streets, Hopetown, before 12:00 on Tuesday **24 May 2019**, after which tenderers will be called out and listed in public.
